ORDINANCE NO. 2021 - 01

AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, ENTITLED "FIXING ANNUAL SALARIES AND HOURLY WAGES FOR CERTAIN OFFICIALS AND CREATING A PAYROLL ACCOUNT

BE IT ORDAINED by the Township Committee of the Township of Washington, County of Burlington and State of New Jersey as follows:

SECTION 1. Effective Date: The salaries provided for herein shall be those in effect for January 1, 2021 through December 31, 2021. All salaries shall be retroactive to January 1, 2021.

SECTION 2. Annual Rate of Compensation. The minimum and maximum accounts of annual rates of compensation, salary or wage for the positions of the Township of Washington are hereby fixed and determined as set forth in the following schedule.
