- d) **Township Clerk** Routine day to day operations of the Township Clerk's Office and submitted monthly reports required. I'll be giving the Committee a sample ordinance with regards to vacant property and requiring the owners (Banks) to register and maybe having a fee. Through the Code Enforcement Office and Zoning Officer they have asked about the Pods and storage containers. They are not permitted now; but I would need direction from the Committee as to what they would like to do.
