Tom Coleman, Esq., "until we receive confirmation from Mr. Bellia that he's taking no further action I'd suggest that Barbara have no further contact with the IT consultant. If she needs to contact him I suggest either a committee member or Kathy be the contact or the liaison until we get some level of comfort that he's not going to pursue this matter legally with the Township. Barry Cavileer, "Personally, I can understand where Mr. Bellia would react in the way that he did, in this day and age that sort of message to anyone has to be taken as a threat. I know we have an explanation that it was a mistake and I'm not willing to say that it wasn't a mistake. This is serious stuff. We have to have zero tolerance for any kind of threat to any of our staff or any of our people that we hire, professionals we hire to do things. I am in accord with the solicitor's suggestion with between Barbara and Mr. Bellia or his worker"

Dan James, "Or until this is resolved."

Barry Cavileer, "Yes. He's satisfied no contact."

Dan James, "Are you good with that?"

Barbara Somes agrees.

Township Clerk Hoffman went to get the Mayor.

Township Clerk Hoffman came back to the meeting and stated that the Mayor must have left.
